## E- TENDER

E-Tenders are invited by the Executive Engineer, HMC, for the following Electrical works under Howrah Municipal Corporation from the Govt. Licensed Electrical Contractors possessing Electrical Supervisors Certificates of competency of Part No. 1, 2, 6A, 6B, 7A, 7B & 11 or National certificate. Intending Tenderers will have to download the documents are to be submitted online with digital signature along with valid G.S.T Certificate & Return (Current Quarter), P.T, I.T, Trade License, Credentials along with completion certificate of similar nature of work & Forty percent of work value in single order executed within last 5 (Five) years regarding their ability to execute the work.

The payment mode will be 50% fund after completion of the project. The upfront payment of 50% should not exceed estimated capital expenditure cost of the materials procured under any circumstances. The balance 50% fund in 5 (Five) Years in 5 (Five) equal annual installment. This 5 annual installments are 6% as 1<sup>st</sup> installment in 1<sup>st</sup> Year, 8% as 2<sup>nd</sup> installment in 2<sup>nd</sup> Year, 10% as 3<sup>rd</sup> installment in 3<sup>rd</sup> Year, 12% as 4<sup>th</sup> installment in 4<sup>th</sup> Year and remaining 14% as 5<sup>th</sup> installment in 5<sup>th</sup> Year or any similar incremental percentages as may be deemed fit by the TIA.

A warranty of LED Light for 5(five) years shall have to be submitted by the bidder.

The OEM authorization letter of tender specified OEM at least of brands should be including with a technical bid & OEM should have serviced by the bidder.

Minimum 1 Tender Specified OEM Authorization requires. (Philips, Bajaj, Crompton, etc. or any reputed make having same technical specification attached) OEM authorization/warranty to be signed by regional manager.

**Tenderer is fully responsible to resolve/repair luminaries during 5(Five) years guarantee period as & when required within 72 hours.**

Above all items should be supply in brand of (Philips, Bajaj, Crompton etc. or any reputed make having same technical specification attached). All Fittings should be made in INDIA (The authority of Howrah Municipal Corporation reserves the right to accept or reject any brand without assigning any reason).
