STANDERD OPERATING PROCEDURE (SOP) FOR SILT REMOVING WORK

- 1. Work shall have to start within 48 hours of the date of receiving the Work Order. Any delay in this regard will have to be communicated in writing to the HMC authority.
- 2. Dedicated staff from the L1 Agency shall be deployed at the site throughout the tenure of the work, details of whom would have to be communicated to the OSD & Ex-Officio Executive Engineer, HMC for perusal.
- 3. Floating material shall be removed continuously as and when required instantly throughout the entire tenure of the work.
- 4. For every case, gunny bags are to be used for blocking drain water after certain interval. The maximum length of blockage drain is to be 50 m.
- 5. Necessary pump set should be provided at site for dewatering percolating water continuously.
- 6. Desilting should be done thoroughly up to bed level of the existing drain continuously.
- 7. Wet silt, which is to be removed from the drain, shall be stacked at the nearest point for maximum forty-eight (48) hours and stage measurement shall be taken there off as per existing norms.
- 8. All vehicles carrying such silt shall pass through the Weigh Bridge at the BTG or any other Weigh Bridge as may be earmarked by the HMC Authority OR, (ii) in case of non-weighting, the vehicle carrying such silt will be provided with an unique RFID sticker for monitoring the movements as mark of testimony for disposal of the same at the BTG.
- 9. Cleaning silt should be done under precast/cast in situ Culvert/slab by using special mechanism.

10. Pictures shall be uploaded in the "PUROBIKHAN APP" of HMC on a daily basis during execution of the work by your dedicated staff,
