Application from the intending tenderers will be received on 24.12.2013 upto 16-00 hours by the Executive Engineer-VIII & XII of the Trust. List of the permitted tenderers will be displayed in the office notice board by 26.12.2013 at 17-00 hours.

Permission shall normally be given only to those reliable, resourceful, experienced and bonafide engineering firms who have, within the last five years, successfully executed at least a single similar work of value not less than 50% (fifty percent) of the estimated cost of the particular work.

Documentary evidence (photocopies) in support of the above as well as financial capability should invariably accompany the application for purchase of tender papers. Originals shall have to be produced for verification. No Tender shall be issued unless upto date Clearance Certificates of Professional Tax, Sales Tax / VAT and Income Tax / PAN Card as statutorily required, are produced and the establishment is registered under BOCW Act, 1996.

The permitted tenderers shall purchase the tender papers from the Head Office of the Trust at 19, G. T. Road (South), Howrah, on 27.12.2013 upto 16-00 hours on payment of the prescribed cost in cash. Earnest money, as stipulated, should invariably be furnished with the sealed offer in the form specified in the tender papers. The Engineer's Co-operatives are however exempted from depositing earnest money.

Tenders will be received upto 14-00 hours on 30.12.2013 and opened at 14-30 hours on the same day by the Deputy Chief Engineer / Executive Engineers at the office of the Trust, at 19, G. T. Road (South), Howrah, in presence of the intending tenderer or their authorized representatives. Web site of Howrah Improvement Trust www.hit.gov.in may be followed in this connection.
