In addition to uploading the scanned copy of Demand Draft, the original Drafts must be submitted separately to this Corporation for cost of Tender Document and EMD in separate sealed envelope clearly super scribing the NIT reference no, name of the work, name of the bidder etc within the following date and time specified under. Without uploading/submission of either the scanned copy or the Original Demand Drafts, the tenders will be treated as non-responsive. The tenderer will have to submit their bid on-line in two cover/folder system containing pre qualification document (Technical Bid) in one and Financial Bid in another.
