CORRIGENDUM NOTICE NO. 01 TO NOTICE INVITING QUOTATION NO.17 OF 2012-2013 OF CENTRAL MECHANICAL DIVISION UNDER SPECIAL ENGINEER, SALT LAKE RECLAMATION AND DEVELOPMENT CIRCLE OF URBAN DEVELOPMENT DEPARTMENT, GOVT. OF WEST BENGAL

FOLLOWING POINTS ARE TO BE INCLUDED UNDER TERMS AND CONDITIONS OF THE NOTICE INVITING QUOTATION NO.17 OF 2012-2013 OF CENTRAL MECHANICAL DIVISION UNDER SPECIAL ENGINEER, SALT LAKE RECLAMATION AND DEVELOPMENT CIRCLE OF URBAN DEVELOPMENT DEPARTMENT, GOVT. OF WEST BENGAL – CIRCULATED VIDE MEMO NO.29-251/1001 DATED 21/08/2012. THIS CORRIGENDUM NOTICE WILL FORM PART OF THE AGREEMENT OF CONTRACT.

INTENDING PARTICIPANTS/BIDDERS ARE REQUESTED TO GO THROUGH THIS CORRIGENDUM NOTICE BEFORE SUBMITTING THEIR BID.

- 1. All materials of approved type required for completion of the work as per specifications shall brought at site by the bidder at their own cost. If the materials or any of the components be lost, damaged or broken during transit for any reason, whatsoever, the same shall be replaced by the bidder at their own cost. The rates quoted for the items shall be inclusive of all costs of materials and labour, tools & tackles, transport charges including loading & unloading at site.
- 2. The bidder shall arrange for guarding and storage of materials and machineries in their safe custody till handing over of the work.
- The bidder shall provide all labourers and materials needed for carrying out survey, setting out, checking of works, taking measurement, testing of equipment without any extra payment. The bidder will also provide approach and access to all works and stores without any extra cost.
- 4. The bidder shall furnish, within 07 (seven) days from the date of work order, a work program schedule. The work program schedule should indicate completion of whole work in the stipulated time, and proportionate progress of work with respect to time.
- 5. All kind testing, as may be directed by the Engineer-in-Charge, in respect of materials and the works done by the bidder shall be at the cost of the bidder.
- 6. Safety of all labourers and other working staff engaged at site is the responsibility of the bidder. The bidder will solely be responsible for any accident of site staff. No liability or arrangement for medical aid will rest on the department.
- 7. The bidder shall furnish, along with the technical bid, the technical information, drawings with designs as may be considered necessary for proper appreciation and assessment.
 - (a) Details of plan, design & drawing of secondary clarifier showing location of clarifier with its bridge scraper, details of motors, valves, pipes etc. with dimensions, size of motor assembly, center line positions of holding down bolts, position of panel board etc.
 - (b) Electrical drawings showing cable tray/trench cable size and number, cable layout, position of switch board/panel, positions of holes to be kept in floor and walls for incoming cable.
 - (c) Detailed drawing indicating the position of holes, pedestals, recess and special fixture, if any, for installation of equipment and machineries in the pumping station.

The successful bidder is to submit detailed working drawings and got approved before execution. 6(six) copies of all the designs and approved working drawings are to be furnished by the bidder to the department free of cost. He will not be permitted to commence actual work at site unless detailed designs and working

drawings are approved by the department. The design shall be subject to modifications, if found necessary. Notwithstanding what has been stated above, bidder shall be responsible for the correctness and soundness of the design submitted by them. The equipments shall be as per recognized engineering practice, and if any provisions are found inadequate or faulty, necessary modifications will have to be carried out even after the expiry of the guarantee period and no extra payment will be made on that account.

- 8. The successful bidder shall supply all necessary commissioning spares for all equipments covered without any extra cost.
- 9. Formal acceptance of the work or equipments by the department will not be made until all the works done by the bidder have satisfactorily passed all tests required by the specification and standard code of practice.

If during testing of work and/or equipment, prior to formal acceptance, any equipment or materials fail in any respect to meet the guarantee, the bidder shall place such equipment in a condition, which will meet the guaranteed performance.

All the equipments shall be operative satisfactorily and performance and efficiency shall not be less than guaranteed values.

- 10. After the completion of the work, the bidder shall run the pumps with all its installations to their designed capacity for a period of 6(six) months after putting the pumps successfully into regular operation. During this period of 6(six) months necessary skilled trained labour and other technical personnel as required shall be provided by the successful bidder at its own cost and arrangement. All the personnel engaged by the successful bidder shall work under the guidance of the bidder's supervisors who will carry out necessary tests, instruct and train the departmental staff in the method of operation, within this period of 6(six) months. The operation for works as a whole will include the service of bidder's supervisors for the above period and no extra payment will be made.
- 11. If any electrical and mechanical spare parts are required within the trial run period, those are to be within the scope of work without any extra cost.
- 12. If any dismantling of pumping set is required within the trial run period, the cost of dismantling and assembling is to be borne by the bidder.
- 13. No interest is payable by the department on the amount due for final settlement.
- 14. The department shall have the right to take possession for use of any completed or partly completed part of the work. Such possession or use shall not be deemed to be an acceptance of any work nor completion of the work.
- 15. The bidder guarantee for the successful operation of the pumps and associated accessories and equipment for 12(twelve) months period inclusive of 6(six) months trial run period from the date of such successful commissioning of the said pumps, within which time any defect or shortcomings due to faulty design of the pumps and other equipments will have to be made good without any extra cost. During the guarantee period, the representative bidder shall visit the work once in 02(Two) months or earlier, as may be required by the department.
