**INVITATION FOR EXPRESSION OF INTEREST (Eoi) FROM REPUTED CONSULTANTS  
SPECIALISTS IN SEWAGE TREATMENT**

The Chief Engineer, Municipal Engineering Directorate, Department of UD & MA, GoWB is planning to avail the "Expression of Interest" for the services of reputed and well established **Consultants Specialists in Sewage Treatment** for low cost sewerage treatment of two outfalls for the Drainage system within Ranaghat, District - Nadia, West Bengal.

1. The Agency may be an institution or consulting organization working or worked on similar assignments with government departments or private institutions. The Agency may have an office operational in KOLKATA.
2. The agency may have a pool of experts from relevant disciplines.
3. The Agency may have a minimum accumulated annual turnover of **Rs. 1 Crore (Rupees One Crore)** for the preceding 4 financial years ending with **31-MAR-2018**.
4. The Agency must have also successfully completed at least one such similar project from start to end with Central/State Govt./ Private institution of at least **Rs.10 lacs** in last four financial years ending on **31-MAR-2018**.
5. The Agency have to submit their management structure, turnover and credentials in this field along with copies of balance sheets/ profit & loss accounts/ annual reports in support of their claim.
6. Agency must provide Project Profile of all such projects. Copies of work orders and successful completion certificates of each such project should be enclosed with the proposal.
7. Agencies should not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Govt. of India/ State Govt. A self-declaration certificate to that effect should be submitted along with the proposal.

**8. SCOPE OF WORK**

Preparation of proposal for 'low cost in-situ treatment unit' for treatment of the sewage of the following drainage outfalls before discharging the sewage to river Churni including site surveying, design, detailed drawing along with cost estimate (supported with proper justification):

- a) Outfall 6 (Kheyaghat-Chaitanya Mandir) with this year flow 0.518 MLD
- b) Outfall 7 (Radharani Ghat) with this year flow 0.333 MLD




