- 1) The Tenderer must produce Trade. Licences professional Tax Challan (Uptodate). VAT.
  - 12) Rate in Part-B (Financial Bid) shall be quoted in figure & words by the bidder in INR. In case of any discrepancy between figure & words, the rate quoted in words will prevail.
  - 13) The rates quoted shall be inclusive of all charges, any type of taxes, duties like VAT, IT, Service Tax registration etc applicable or as would be applicable from time to time during the period of contract.
  - 14) If the applicant is an authorized signatory he should submit document of authorization in his favour along with the application. In case of partnership firm copies of the partnership deed are to be submitted along with the tender document.
  - 15) Conditional tender will not be considered for acceptance. Tenderers should note that conditional tender will be rejected without showing any reason for such rejection.
  - 16) The tenderer inviting authority reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.
  - 17) The authority is not bound to accept the lowest rate offered by the tenderer.
  - 18) All documents submitted along with the tender must be "Certified as correct" by the tenderers. Self attested documents are to be submitted by the applicant. All the intending applicants are required to produce original documents as & when desired by the authority.
  - 19) Authority will have the sole discretion to decide the eligibility of the bidders on the basis of his submitted documents & reserve the right to refuse without any explanation to the tenderer for the ineligibility after scrutiny & the decision of the authority in this respect will be final.
  - 20) Tender once submitted by the tenderer will not be allowed to be withdrawn within a period of 4(Four) months, i.e.-120 days from the date of opening of the Tender/Sealed Bid/Open Bid as applicable. The rate shall remain valid for 4 months from the date of opening of tender (financial bid).
  - 21) Canvassing in connection with tender is strictly prohibited & the tender submitted by the tenderers who resort to canvassing will be liable to rejection.
  - 22) Tenderers who do not fulfill any of the above conditions or are incomplete in any respect are liable for rejection.
  - 23) Tender inviting authority will not be responsible for any sort of delay or difficulties faced during the submission of online tender by the tenderers.
  - 24) Cost of Agreement paper Sl. No.1,2 to 11 @ of Rs. 1005/- each. & Sl.No. 2 & 3 @ Rs.2505/- Each
  - 25) Constructional labour Welfare CESS @ 1% (One Percent) of Cost of Construction will be deducted from every Bill of the Selected agency.
