**1.1 Credential/ Eligibility Criteria**

Registered bona fide, reliable and resourceful Electrical / Mechanical or Electro- mechanical contractor /agencies/firms/ Authorised dealer/ Manufacturer *having sufficient experience in execution of similar type of works* may participate in this NIQ.

**Note:** Failure of submission of any one of the above mentioned documents will render the bid liable to summary rejection

## 2.0 General Terms & Conditions Submission of Bids

- a. Bids are to be submitted offline within the stipulated date and time as given in the notice. The bidder shall carefully go through the documents. He needs to fill up the rates in the BOQ, both figure and word.
- b. Failure to produce any of the above documents may be considered good and sufficient reason for non-issuance of quotation papers.
- c. Any corrigendum notice that may be issued in connection with this N.I.Q shall also form part of the agreement of contract.
- d. Conditional bid / quotation, which does not fulfill any of the above conditions, and is incomplete in any respect, is liable to be summarily rejected. .
- e. The bidders are bound by the terms and conditions of W.B.F No. 2911 along with the specification, notice of NIQ along with all enclosures, Special Terms & Conditions, if any, and schedule of works etc. which forms a part and parcel of this contract. Conditional offer will not be entertained and shall be deemed as 'informal'
