I. Scope of the work:

1. Preparation of design, working drawing specifications etc. for civil works comprising of plan, sectional elevation, structural detailing along with design calculation.
2. Preparation of detail quantity estimate for civil works.
3. The agency shall execute the whole and every part of the work in consultation with the Technical Advisor / Deputy Technical Advisor, N.D.I.T.A. Unnayan Bhavan, 1st floor, Sector-II, Salt Lake, Kolkata-700091.
4. Check prints, in convenient scale, are to be supplied as and when required. Final drawings shall be incorporate all changes / corrections and submit four sets of hard copy & a soft copy.
5. Inside diameter of each pumping station will be 5.0m and requisite depth to be fixed as per hydraulic calculation.

II. Elegibility Criteria.

1. Quotation will be accepted only to the eligible parties (eligible means experience and the technical capability) on the basis of work done in last five years, on production of Xerox copy of valid Income Tax, P.T. Clearance Certificate, Pan Card , Vat registration, Sale Tax Registration Certificate, work Order and successful completion certificate of similar nature of work. All the papers regarding the above credentials should also be produced in original if required before final permission.
2. Must have in- house engineering and management personnel.
3. Must be a regular payee income tax (copy of I.T. Returns for the last three years shall need to be provided)/ have paid VAT in form 3.
4. The applicant full filling the above eligibility only shall be considered for the purpose of the project. They shall have to furnish supporting documentary evidence in support of eligibility.

III. Submission of quotation

IV. Validity of Acceptance:

V. EARNEST MONEY

- a) The quotationer shall have to deposit an earnest money at the rate of 2% of the quoted value of work put to quotation.

- b) The earnest money shall be in the shape of Bank Draft / Pay Order in favour of **“NABADIGANTA INDUSTRIAL TOWNSHIP AUTHORITY”** encashable from Kolkata. No cash or cheque or token will be accepted as Earnest Money.

V. **SECURITY DEPOSIT**

- a) The successful quotationer will have to provide security for the work an amount in terms of clause – 1 of the printed tender form.
- b) The earnest money at 2% of the amount put to tender already deposited shall be converted into part of the security deposit.
- c) Security Deposit will be 10% of the quoted value. The earnest money @ 2% of quoted value already deposited by the successful bidder shall be converted into initial security deposit. The balance sum required to make the security for the work done shall be recovered progressively by deduction from each running account bill at 8% (Eight Percent) of each such bill.
- d) N.D.I.T.A. would refund the security deposit to the quotationer within the 30 (thirty) days of the contractual period.

VI. **INCOME TAX**

Income tax will be deducted from the Contractor's bill at the rate in accordance with the orders / circulars of the Govt. of India in force during the contractual period. The quotationer shall declare his permanent income tax account number, issued by the income tax authority, in the tender.
