# 3. Credentials, certificates, testimonials etc. as required along with application for Quotation documents (Enclosure must be serially mentioned in the application):

The minimum limit of total value of work, for which certificates to be attached, should be not less than 50% of corresponding value of work now included in the notice, each year. The certificates should invariably include work orders supported by payment certificates, performance certificate issued by relevant authorities from where orders / payment certificates have been originated.

- ii) Proof of financial capability through bank documents.
