Moreover, remaining amount of security deposit shall be deducted from the running account bill of the agency to cover up 10%(ten percent) of the total value of the work executed. Please note except L<sub>1</sub>, all participants may exchange the said through bank Demand Draft & only L<sub>1</sub> has to submit his/her Demand Draft within 3(Three) working days to this office after issuance of LOA/work order.

Intending tenderers must apply in writing together with documentary evidences in support of their experience and competency to execute such type of works along with valid GST, I.T. & P.T. clearance Certificate for obtaining permission from the undersigned to purchase tender documents for the work . Details of work, specification etc. can be seen from the office of the undersigned. Tender papers shall be purchased from the office of the Executive Engineer, Central Mechanical Division.

Rates should be quoted in figures as well as in words at percentage above/below or at par within the rates shown in the schedule of the above mentioned work; no tender with price variation clause will be entertained.
