NOTICE INVITING TENDER NO. 03 of 2017 -2018 OF SUB-DIVISIONAL OFFICER, SALT LAKE RECLAMATION SUB-DIVISION-I

1. Separate Sealed Tenders in printed form [W.B. Form No. 2911(ii)] are hereby invited by the Undersigned on behalf of the Governor of West Bengal, for the works as per list enclosed herewith from eligible bonafide, reliable and resourceful contractors having sufficient experience in execution of similar type of works, detailed herein under. - a) Intending Tenderers should apply for Tender papers in their respective Letter Heads enclosing copies of the following documents, duly Self Attested, Originals of which and other documents like Registered Partnership (for Partnership Firms) etc. are to be produced on demand. Original Documents should be neat and clean without any tampering by scraping/whitening in VAT Registration, Registration as "Works Contractor/Civil Contractor" should be clearly mentioned.
- b) GST Registration no certificate/Acknowledgement of GST application, and PT clearance certificate and IT PAN valid at least up to the date of opening of the Tenders. Application for such clearance addressed to the competent authority, subject to production of authenticated receipt, may also be considered.
- c) Completion Certificate/Payment Certificate(s) for one single similar work worth at least 50% of the value of the work for which Tender Papers is desired, executed within last 5 (five) years (to be determined from the actual year of completion, considering current financial year as Year-1).
- d) Government Order indicating Fixed Security Deposit (if any).
- e) Eligibility Certificate issued by the A.R.C.S. (for Engineers' Co-operatives and Labour Cooperatives);
- A statement showing number and value of works presently under execution by the Tenderer under the Government Department/Organizations as stated hereunder;
- g) <u>Declaration by the applicant to the effect that there is no other applications for Tender paper for</u> work in the NIT in which he/she/they has/have common interests.
- Failure to produce any of the above documents may be considered good and sufficient reason for non-issuance of tender paper.
- 3. Credentials of work executed under Irrigation & Waterways Department will be accepted. Credentials of work executed under Public Works Department/Public Works (Roads) Department, P.W(C.B), P.W.D.(Housing), Public Health Engineering Department, P & RD, K.M.D.A., H.R.B.C., K.M.C., Different Municipalities/Corporation in West Bengal, Zilla Parishads, WBHIDCO, Central Government Department, Mackintosh Burn Ltd., Westinghouse Saxby Farmer Ltd, may also be considered. Completion certificates, containing name of work, tender number, actual year of completion (as per MB) and gross final value of works, are to be issued by competent authority as per prevailing norms. Such certificates are to be countersigned by the Executive Engineers (or, Payment Authority e.g. Executive Officer etc.) of the State Government Departments, If those are issued by some other authority.
- 4. Intending tenderer not satisfied with the decision of the Tender Paper Issuing Authority may prefer an appeal to the next Superior Officer. It should be brought to the notice of such Authority within two working days after the date of issue of tender paper, a copy of such communication should also be submitted to the Tender Paper Issuing Authority within the same period, failing which no such appeal will be entertained.
- 5. a) Tender paper can be had by the shortlisted intending tenderers or by their duly authorised representatives, on cash payment of requisite amount (non-refundable) from the office of the Executive Engineer as shown in the broad sheet published by the tender issuing authority against the name of each intending tenderer, within the specified date and time.
 - b) No tender paper will be supplied by Post.
 - c) No tender paper will be issued on the date of opening of tenders and after expiry of date and time mentioned in the Notice. Before submitting any tender, the intending tenderers should make themselves acquainted, thoroughly, with the local conditions prevailing, by actual inspection of the site and take into considerations all aspects including transportation of materials, communicating facilities, climate conditions, nature of soil, availability of local labourers and market rate prevailing in the locality etc As no claim whatsoever will be entertained on these accounts, afterwards.
 - Earnest Money, as noted in the list of works, in the form other than those mentioned below, will not be accepted.
 - a) Receipted Challan of Reserve Bank of India or Treasury showing the deposit to be credited under the Head 'P.W. Deposit' in favour of the Executive Engineer, Salt Lake Reclamation Division.
 - b) Government Security duly pledged to the Executive Engineer, Salt Lake Reclamation Division.
 - c) Crossed bank Draft/Deposit at call Receipt, Banker's Cheque of any <u>Scheduled Nationalised Bank</u> in the locality in favour of the Executive Engineer, Salt Lake Reclamation Division.
 - d) No adjustment of any sort of above mentioned Earnest Money previously deposited for other works will be considered. Tender without the specified earnest money will be treated as informal.

Earnest Money for works, as noted in the list of work, will have to be deposited by the contractors, Unemployed Engineers' Cooperatives & Labour Cooperatives with the tender. Anybody desirous of exemption from depositing Earnest Money, is to furnish along with his Tender, self attested copy of document exempting him from depositing Earnest Money for the tender.

Earnest money deposited by the agency will be converted into security deposit for the lowest tenderer. Additional security money totalling 05(five) percent of the tendered amount, including earnest money deposit, shall have to be deposited by the executing agency at the time of executing duplicate/triplicate copies of his/her/their tender without which no work order will be issued. Moreover, remaining amount of security deposit shall be deducted from the running account bill of the agency to cover up 10%(Ten percent) of the total value of the work executed.

- The tenderer should quote the rate both in figures and in words on the basis of percentage above/below or At Par on the Schedule of Rates attached with the Tender Form and also in the space provided in the Tender Form. The rate should be quoted in one single handwriting and preferably with the same ink. Rates quoted in different hand writing shall be treated as informal.
- 9 Any tender containing over writing is liable to be rejected.
- All corrections are to be attested under the dated signature of the Tenderer without which tender may be in formal.
- When a Tenderer signs his Tender in an Indian Language, the total amount tendered should also be written in the same language. In the case of Illiterate Tenderer, the rates tendered should be attested by a witness.
- The tenderer who will sign on behalf of a Company or Firm, must produce the registered documents (within 3 days from the date of opening the tender) in support of his competency to enter into an Agreement on behalf of the Company or the Firm under the Indian Partnership Act, failing which the Tender will not be considered and the deposited Ear nest Money will be forfeited.
- 13 Any letter or other instrument submitted, separately, in modification of the sealed tender may not be entertained.
- 14 Conditional Tender, which does not fulfil any of the above conditions, and is incomplete in any respect, is liable to be summarily rejected.
- 15 GST, Royalty, Building Working Cess and all other statutory Levy/Cess etc. will have to be borne by the Contractor (he/she will have to produce necessary documentary evidence of his having done so at the time of receiving the final payment for the work).
- The Tender Accepting Authority does not bind himself to accept the lowest tender and reserves the right to reject any or all of the tenders received, without assigning any reason whatsoever to the intending Tenderers and also reserves the right to distribute the work amongst more than one Tenderers.
- 17 The Tenderer will have to, if so desired by the Tender Accepting Authority, submit his/her/their analysis to justify the rate quoted by him.
- The Tenders will be opened, as specified in the list of works, in presence of the participating tenderers or their duly authorised representatives, who may be present at the time of opening and who may also put their signatures in the Tender Opening Register.
- The successful tenderer will have to execute the duplicate/triplicate/quadruplicate copies of his tender which will have to be obtained by additional cash payment in the office of the Executive Engineer, Salt Lake Reclamation Division, within 7(seven) days from the date of receipt of the intimation of acceptance of his tender, failing which the Earnest Money shall forthwith stand forfeited in favour of the Government and the communication of acceptance of the tender shall automatically stand cancelled.

- If any tenderer withdraws his tender before its acceptance or refuses/fails to convert it into a contract within a 20 reasonable time, without giving any satisfactory explanation for such withdrawal /refusal /failure, he/she/they shall be disqualified for submitting any tender in this Division/Circle for a minimum period of one year and his case will be referred to the Government for order as to what further action will be taken against him.
- The successful tenderer will have to abide by the provisions of the West-Bengal Contract Labour (Regulation and 21 Abolition) Rules, 1972 and such other Acts as may be applicable, as will be in force from time to time.
- In the following cases a tender may be declared informal and unacceptable. 22
- Correction, alterations, additions, etc. if not attested by the Tenderer. a.
- Earnest Money in the form of Government Security etc. not held by the tenderer and not properly pledged, Earnest b. Money in the form of T.R.Challan, D.C.R/Demand Draft, etc. which are short deposited and/or not deposited in favour of the Executive Engineer, Salt Lake Reclamation Division.
- If the Tender Form is not properly filled in respect of the general description of the work, Estimated Cost, Rate of deduction of Security Deposit, etc. and other pages as are required to be filled in.
- If the specified pages of the Tender Document are not signed by the tenderer. d.
- If the tender is not submitted in a Cover properly sealed and the name of the work is not indicated on the cover, e.
- For the return of the Earnest Money of the unsuccessful Tenderer(s), he/they is/are to apply for the same to the 23 Executive Engineer, Salt Lake Reclamation Division giving the reference to the work, N.I.T. No., date of tender, amount and mode of Earnest Money deposited - all in a complete form. The Earnest Money of all Tenderers other than the lowest tenderer in each case, may be refunded, after acceptance of the rate in the comparative statement, as early as possible.
- To verify the competency, capacity and financial stability of the intending tenderer(s), the Tender Paper Issuing 24 Authority may demand production of any necessary document(s) as it may deem necessary.
- The payment of R/A as well as Final Bill for any work will be made according to the availability of fund and no claim due 25 to delay in payment will be entertained.
- Recent modification of Clause -17 of contract as per P.W.D., CRC Branch Order No. 177-CRC/2M-57/2008, dated 26 12.07.12 may be applicable for these work and will be as per decision of Engineer-in-Charge.
- If in any reason any date as mentioned herewith and related with this tender falls or declares as holiday then the next 27 day will be treated as the working day for this purpose.

Additional terms & conditions including Modifications of Clause No 17 and Clause No 25 of West Bengal Form No 2911/2911(ii)/2911(ii)

(This bears concurrence of Group T of Finance (Audit) Department vide their U.O. No 614: Dated 06.07.2012.)

1) Clause -17 of Contract of the Printed Tender Form shall be submitted by the following:-

Clause 17.-If the contractor or his workmen or servants of authorised representatives shall break, deface, injure or destroy any part of the building in which they may be working or any building, road curbs, fence, enclosure, water pipes cables, drains, electric or telephone post or wires, trees grass of grassland or cultivated ground contiguous to the premises on which the work or any part of it is being executed, or any damage shall happen to the work from any cause whatsoever or any imperfections become apparent in it any time whether during its execution or within a period of three years after issuance of certificate of its completion issued by the Engineer- in- charge shall mend good the same at his own expenses, or in default, the Engineer- in- charge may cause the same to be made good by other workmen and deduct the expense of which the certificate of the Engineer- in- charge shall be final from any sums, whether under this contract or otherwise, that may be then, or at any time thereafter became due to contractor by the Government or from his security deposit, or the proceeds of sale thereof or of a sufficient portion thereof and if the cost, in the opinion of the Engineer- in- charge (which opinion shall be final and conclusive against the contractor), or of making such damage or imperfections good shall exceed the amount of such security deposit and/ or such sums, it shall be lawful for the Government to recover the excess cost from the contractor in accordance with the procedure prescribed by any law for the time being in force.

The security deposit of the contractor shall not be refunded before the expiry of three years after the issuance of the certificate, final or otherwise of completion of the work by the Engineer- in- charge.

Provided that the work shall not be deemed to have been completed unless the "Final Bill" in respect thereof shall have been passed and certificate for payment by the Engineer- in- charge.

Provided further that the Engineer- in- charge shall pass the "Final Bill" and certify thereon, within a period of forty-five days with effect from the date of submission thereof by the contractor under this contract and shall also issue a separate certificate of completion of work to the contractor within a period of forty- five days. The certificate of Engineer- in- charge whether in respect of the amount payable to the contractor against the "Final Bill" or in respect of completion of work shall be final and conclusive against the contractor. However, the security deposit of the contractor held with the Government under the provision of Clause-1 hereof shall be refundable to the contractor in the manner provided here under.

- (i) 30% of the security deposit shall be refunded to the contractor on expiry of one year after the issuance certificate of completion of work.
- (ii) Further 30% of the security deposit shall be refunded to the contractor on expiry of two years.
- (iii) The balance 40% of the security deposit shall be refunded to the contractor on expiry of three years.

N.B.- Provided that in respect of the of work of repair or maintenance in nature or a combined thereof, the words "Three years" wherever in this clause shall be deemed to be one year and in which case the security deposit of the contractor held with the Government under the provision of Clause-1 hereof shall be refundable to the contractor on expiry of one year after the issuance of certificate of work by the Engineer- in- charge.

"Modifications of Clause Relating to Settlement of Disputes under Condition of Contract."

Clause 25 for work value more than 100 Lacks of W.B.F. No. 2911/2911(i)/2911(ii) will be read as "Clause25"- Except where otherwise provided in the Contract all questions and disputes relating to the meaning of specifications, designs, drawings and instructions therein before mentioned and as to qualify of workmanship or materials used on the work or these conditions or otherwise concerning to work, or after the completion or abandonment thereof shall be dealt with as mentioned hereinafter.

If the contractor considers any work demanded of him to be outside the requirement of the contract, or disputes in any drawings, record or decision given in writing by the Engineer- in- charge or any matter in connection with or arising out of the contract or carrying out of the work, to be unacceptable, shall be promptly requested within 15(Fifteen) days to the Chairman of the "Dispute Redressal Committee" shall give its written instruction or decision. Thereupon, the "Dispute Redressal Committee" shall give its written instruction or decision within a period of Three (03) months from the date of receipt of the Contractor's letter.

"Dispute Redressal Committee" in each of the works' Department should be having the following officials as members:-

1.	Additional Chief Secretary/ Principal Secretary/ Secretary to the Concerned Department	Chairman	
2.	Engineer-in Charge/Chief Engineer or any officer equivalent rank in the Department.	Member	
3.	One Designated Chief Engineer / Engineer of the Department to be nominated by the Department concerned	Member Secretary and Convener	
4.	One representative of the Finance Department of the Government not below the rank of Joint Secretary or Finance Advisor in case of the Works' Department where FA System has been introduced.	Member	

The Provision will be applicable irrespective of the value of the works to which the dispute may arise.
