Govt. of West Bengal as well as from bonafide, experienced, resourceful and licensed outside Electrical Contractors posses Electrical Supervisors Certificate of Competency in parts relevant to work or equivalent national Certificate for the works mentioned in enclosed list.

Intending participants having 50% credential in a single similar type of work in a financial year during last 5 (five) years (to be determined from the actual year of completion, considering current financial year as one year.) are needed and also credential needed as per list. (Total 22 nos. job)

Name of work and work sl. No. should be super scribed on the sealed cover of the tender. Amount put to tender, earnest money, cost of tender documents, last date of application, date of issue, date of submission, date of opening etc are mentioned in the enclosed list. Moreover, remaining amount of security deposit shall be deducted from the running account bill of the agency to cover up 10%(ten percent) of the total value of the work executed. Please note except L₁, all participants may exchange the said through bank Demand Draft & only L₁ has to submit his/her Demand Draft within 3(Three) working days to this office after issuance of LOA/work order.

Intending tenderers must apply in writing together with documentary evidences in support of their experience and competency to execute such type of works along with valid VAT, I.T. & P.T. clearance Certificate for obtaining permission from the Executive Engineer, Central Mechanical Division to purchase tender documents for the work. Details of work, specification etc. can be seen from the office of the Executive Engineer, Central Mechanical Division.

Rates should be quoted in figures as well as in words at percentage above/below or at par within the rates shown in the schedule of the above mentioned work; no tender with price variation clause will be entertained.

Acceptance of the lowest or any other tender is not obligatory and reserves to right to reject any or all of the tender received, without assigning any reason whatsoever to the intending tenderer Payment will be made according to the availability of fund and no claim, whatsoever, due to delayed in payment, will be entertained.
