Intending tenderers must apply in writing together with documentary evidences in support of their experience and competency to execute such type of works along with valid valid GST & PAN for obtaining permission from the Executive Engineer, Central Mechanical Division to purchase tender documents for the work . Details of work, specification etc. can be seen from the office of the Executive Engineer, Central Mechanical Division.

Rates should be quoted in figures as well as in words at percentage above/below or at par within the rates shown in the schedule of the above mentioned work; no tender with price variation clause will be entertained.
