NOTICE INVITING EXPRESSION OF INTEREST (EOI)

Name of Work: "Architectural Design of the Proposed Adibashi Bhawan (G+5) in Plot No. 2221, Action Area IIIA, New Town, Kolkata."

Tribal Development Department, Government of West Bengal intends to build **Adibashi Bhawan (G+5) in Plot No. 2221, Action Area IIIA, New Town, Kolkata** and, for this purpose, the undersigned invites Expression of Interest (EOI) from reputed architectural firms for architectural design and drawing of the said building through electronic bidding (e-Bidding).

Intending bidders who desires to participate in the bids are requested to log on to the departmental website www.wburbandev.gov.in & Govt. Bid website <https://wbbids.gov.in> for information about the bid.

Bidders willing to take part in the process of e-Bidding are required to obtain Digital Signature Certificate (DSC) from any authorized Certifying Authority (CA) under CCA, Government of India (viz. NIC, nCode Solution, Safescrypt, e-Mudhra, TCS, MTNL, IDRBT). DSC is given as a USB e-Token. After obtaining the Class 2 or Class 3 Digital Signature Certificate (DSC) from the approved CA they are required to register the fact of possessing the Digital Signature Certificates through the registration system available in the website. Bids are to be submitted separately for each work online and intending bidders are to download the bid documents from the website stated above, directly with the help of the e-Token provided. This is the only mode of collection of bid documents.

1.0 Scope of Activities

The successful architectural firm will have to undertake architectural design, electrical design, structural design including vetting of the structural design by reputed educational institution, preparation of all detailed working drawings of the said building and preparation of Bill of Quantities (BOQ) for both civil & electrical as per PWD schedule in vogue including rate analyses of items not included in the PWD schedule. The architectural design should take into consideration multifarious facets of aesthetics, compatible with the daily life, art and culture and means of earnings of the tribes residing in our state. In this regard a design brief (Annexure-I) is annexed with this notice which may be perused, before participation.

The building should comply with Newtown Kolkata Development Authority (NKDA) Building Rules, in force, and, the architectural design should also comply with latest edition of the National Building Code. A site plan is enclosed as Annexure-II.

2.0 General Terms & Conditions

Submission of Bids

1. General process of submission

Bids are to be submitted separately for each work online through the website stated above. All the documents uploaded by the Bid Inviting Authority form an integral part of the contract. Bidders are required to upload all the bid documents along with the other documents, as asked for in the bid, through the above website within the stipulated date and time as given in the Bid. Bids are to be submitted in two folders at a time for the work, one is Technical Bid and the other is Financial Bid. The bidder shall carefully go through the documents and prepare the required documents, and upload the scanned documents in Portable Document Format (PDF) to the portal in the designated locations of Technical Bid. He needs to fill up the rates in the BOQ, downloaded for the work, in the designated Cell and upload the same in designated location of

Financial Bid. The documents uploaded must be virus scanned and digitally signed using the Digital Signature Certificate (DSC). Bidders should specially take note of all the addendum and corrigendum related to the bid and upload the latest documents as part of the bid.

2. The undersigned reserves the right to disallow participation of any or all the applicants in the EOI, without assigning any reason whatsoever and no challenge against such refusal will be entertained. The applicants will also not be entitled to any compensation for rejection of their prayer for participation in the EOI.
3. In case of sudden closure of office due to reasons beyond the control of the undersigned, the last date and time as indicated hereinafter, will automatically be deferred to the next working day without further notice.
4. Participation in this EOI deems that the applicant is fully agreeable to abide by all terms and conditions as stated in this notice inviting EOI.
5. Any notice or instruction to be given to the participants under the terms of this EOI shall be deemed to have been served if it has been delivered to his authorized agent (on the strength of authorization) or representative or sent by registered letter to his address as furnished.
6. The undersigned reserves the right to annul the whole process of EOI without assigning any reason whatsoever.
7. The bidders are bound by the terms and conditions of W.B.F No. 2911 along with the specification, notice of EOI along with all enclosures, Special Terms & Conditions, if any, and schedule of works etc. which forms part and parcel of this contract. Conditional offer will not be entertained and shall be deemed as 'informal'
8. **The payment shall be milestone-based. Maximum of 80% (eighty percent) payment shall be made on achieving 100% (hundred percent) of each mile-stone. Balance 20% (twenty percent) payment shall be released on completion of the whole project and on carrying out modifications, if any, successfully without any extra cost. If no component of the work is executed by the selected bidder, for whatsoever reason, no payment shall be made.**

10. No conditional bid/offer/proposal shall be accepted.
11. Any bid/offer containing over writing is liable to be rejected. All corrections are to be attested under the dated signature of the bidder without which bid/offer may be informal.
12. **01(one) model of the proposed building of Adibashi Bhawan(G+5) in Plot No. 2221, Action Area IIIA, New Town, Kolkata is to be supplied by the selected bidder, totally, free of cost to the undersigned.**

Technical Bid

Earnest Money Deposit (EMD)

Earnest money of Rs. 25,000.00 (Rupees Twenty five thousands) only is to be submitted by the participating bidders with their quotation, in the shape of Bank Draft /Bankers cheque purchased from any nationalised bank drawn in favour of the Executive Engineer, Salt Lake Reclamation Division, payable at Kolkata, without which the bid shall be declared as informal. The Earnest money submitted by the bidder whose bid/quotation is accepted, shall be converted into Security deposit and shall be refunded/returned at the end of contractual period after successful execution of work in the field. Unsuccessful bidder may submit application for refund of their Earnest money deposit to the Executive Engineer, Salt Lake Reclamation Division, and that shall be released after issuance of work order to the lowest bidder, whose bid/quotation is accepted. No adjustment of any short of above mentioned Earnest money previously deposited for other works will be considered.

1. Professional Tax (PT) submission of Challan and PAN Card details. Application for such addressed to the competent authority may also be considered.

1. Registered Deed for Partnership Firm / Consortiums from Registrar of Assurances having office at Todi Mansion, Kolkata. Mere application for registration will not be considered. However, in cases where the applicant is yet to receive registration certificate from Todi Mansion, the applicant is to submit an affidavit in Non-Judicial Stamp Paper along with the application pledging that "the registration certificate of the Consortium / Partnership Firm" would be submitted to the Bid Inviting Authority before making agreement with the Bid Accepting Authority in case he is found lowest." In case of inordinate delay in submitting the document, his bid is liable to be rejected and his EMD deposited will stand forfeited to Government. Any change in the constituents of the Consortium / Partnership Firm should also be registered from the Office at Todi Mansion, Kolkata, prior to the date of application of bid otherwise his application will be rejected.

The architect(s) who are having registration from Council of Architecture will have to submit self-attested photocopy of the same. The originals will have to be produced for verification by the successful participant only. The originals will be returned after verification.

iii. **Credential/ Eligibility Criteria**

Registered bonafide, reliable and resourceful architectural agencies/firms **having sufficient experience in execution of similar type of works** may participate in this Expression of Interest (EOI).

Addenda / Corrigenda: If published.

Note : Bidders are to keep track of all the Addendum / Corrigendum issued with a particular bid and upload all the above digitally signed along with the NIT. Bids submitted without the Addendum / Corrigendum will be treated as informal and liable to be rejected.

Others: Any other documents found necessary.

Note: Failure of submission of any one of the above mentioned documents will render the bid liable to summary rejection.

Financial Bid

The Financial Bid should contain the following document in one cover (Folder)

The contractor is to quote the rate online through computer in the space marked for quoting rate in the BoQ. (Only downloaded copies of the above documents are to be uploaded, virus scanned and digitally signed by the contractor).

3.0 **Selection/Acceptance of the successful Bid/Offer/Proposal**

The selection/acceptance of the bid/offer/proposal shall be made by a panel of expert to be constituted by the government.

For selection/finalization of the offer/bid, all the interested participants will have to make presentation of their architectural design/proposal before the panel of expert to be constituted by the government. During presentation, the participant bidder will have to present their concept to visualize the proposed Adibashi Bhawan(G+5) in Plot No. 2221, Action Area IIIA, New Town, Kolkata, three dimensionally, from different angles. The participants will have to arrange for laptop computer, projector etc. and all other necessary tools and tackles for their presentation.

Venue: the Conference Room at 1st floor of 'Nirman Bhawan' Plot No.DF-01, Sector-I, Bidhannagar, Kolkata-700 091 on 15.09.2015, 12:00 hrs onwards.

The evaluation of the technical bid will be done by the expert committee on the quality of the submitted drawings /perspective views etc. and the marking are as follows.

Qualifying mark in technical bid will be 60 marks out of 100 marks. Financial bid of technically qualified bidders, only, will be opened for selection.

The accepting authority reserves the right to reject any or all of the bid/offer/proposal received without assigning any reason whatsoever to the intending participants including lowest bid/offer/proposal received.

4.0 **Terms of Payment**

The payment shall be milestone-based as shown under *Description of Items/Events* in the table below. Maximum of 80% (eighty percent) payment shall be allowed against each item/event, in Q2 (two) instalments, each instalment amount not exceeding 40% (forty percent) on achieving 100% (hundred percent) of each mile-stone and rest 40% (forty percent) in second instalment shall be released on submission of next item/event of work within schedule date. Balance 20% (twenty percent) payment shall be made on completion of construction of the whole project in the field, including carrying out all modifications, if any, successfully, without any extra charge. If no component of the work as shown in the table below is executed by the selected bidder, for whatsoever reason, no payment shall be made.

Special Terms and Conditions

1. All participants are requested to visit the site and satisfy themselves about local conditions and also other matters that may be required in connection to the work. Such matters should be duly taken care of during the work.

2. Any corrigendum regarding this EOI will be uploaded in the website of Urban Development Department i.e www.wburbandev.gov.in and W B Govt. bid website <https://wbbids.gov.in> along with publication through office notice board. The intending participants are requested to visit the websites for any updates etc. in this regard.
3. All changes in the architectural design and subsequent structural design will have to be done free of cost by the selected bidder/firm. Also, any changes those are unavoidable must be done by the selected bidder free of cost.
4. All N.O.Cs related to fire, environment etc. are to be arranged by the successful agency.
5. The selected bidder/ firm has to submit Completion Drawing (five hard copies) and two soft copies to Special Engineer, Salt Lake Reclamation & Development Circle at the end of the project.
6. Payment shall be made on availability of fund.
7. Time is the essence of contract. Proportionate progress must be achieved with elapse of proportionate time, failing which penalty @ 01% (one percent) per month subject to a maximum amount of 10% (ten percent) of the total contractual amount shall be deducted from the bill of the agency for the delay in achieving the target.
8. The intending bidders are to quote their offer taking all the above points into consideration and no extra claim whatsoever shall be admissible afterwards.

The building should be a Multipurpose structure. It would be a State-of-Art Building. The building should reflect the ethos of Tribal Culture and the design and colour combination must be reflect the diversity of Tribal Culture of West Bengal.

A plot of land in Plot No. 2221, Action Area IIIA, New Town, Kolkata measuring, approximately, 20 (twenty) cottah has been earmarked for that.

The authority has a dream that this multifunctional city of New Town will get a unique landmark building with good aesthetics. It will be an eye catching building which may enhance the urban scope. The aim of the authority is to have a building with unique combination of the best natural resources and the modern technology. The building should be an Eco- Friendly one with building materials those are environmental friendly and locally resourced. We aim to create a healthy, efficient building that will help to promote a green corporate image to all. The proposed building should be air-conditioned & fire protected.

The design of the landmark building should cater to the following demands.

- o Functional Demand
- o Spatial Demand
- o Physical Demand
- o Cultural Demand

LOCATION (Site & the surroundings):

The proposed Adibashi Bhawan is to be located at Plot No. 2221, Action Area IIIA, New Town, Kolkata measuring approximately 20(twenty) cottah. The shape of the plot is almost rectangular.

LAND AREA: 20 (twenty) cottah, approximately.

USE OF BUILDING: Business Building.

PERMISSIBLE F.A.R.: Maximum permissible FAR is to be achieved in the design.

PERMISSIBLE GROUND COVERAGE: 45% of the Plot Area.

REQUIRED BUILT UP AREA: At least 30,000 (thirty thousand) Sq. ft.

PARKING FACILITIES: As per the prevailing Newtown Kolkata Development Authority (NKDA) Building Rules, in force.

OPEN SPACE SYSTEM: Beside the marginal open spaces, green open spaces, landscaped gardens using water features etc. shall have to be included in the project as per the prevailing Newtown Kolkata Development Authority (NKDA) Building Rules in force.

CIRCULATION SYSTEM: Circulation within the project should be smooth, easy and flawless. Internal roads, drive ways, path ways etc. should cater all the connections within the project.

FUNCTIONAL ACTIVITY SYSTEM: The building must provide the space for 04 (four) offices with provision for 02 (two) chambers with attached toilets, multi-purpose hall for the staff of the departments/sections, an auditorium, conference room, toilet Blocks for both gents and ladies in each floor, canteen for the office staff, server room, driver's rest room, security or guard room, a ten room guest house, a ten bed dormitory etc

OTHER FACILITY: ATM counter, Medicine shop, Photocopy shop, Stationery shop, etc. to be provided in the ground floor of the building. Lift- 2 nos. (8 passenger) with machine room.

SERVICE SYSTEM: To maintain smooth building operation – Electrical sub-station room, Generator room, Pump room, fire pump room, HVAC (VRF) room, drainage and sewerage system must be provided in the project.

FIRE FIGHTING ARRANGEMENT : Fire fighting system should be equipped with Fire alarm, Hydrant, Sprinkler system, Fire rated door, Fire Damper, Smoke extraction system, CO₂ foam system etc. as per fire safety norms.

Grid connected Solar Panels atop the building providing energy for compound illumination.

SECURITY SYSTEM: Close circuit TV monitor system at the entrance & in common spaces manual security guard tour system along with guard rooms etc. must be included in the project.

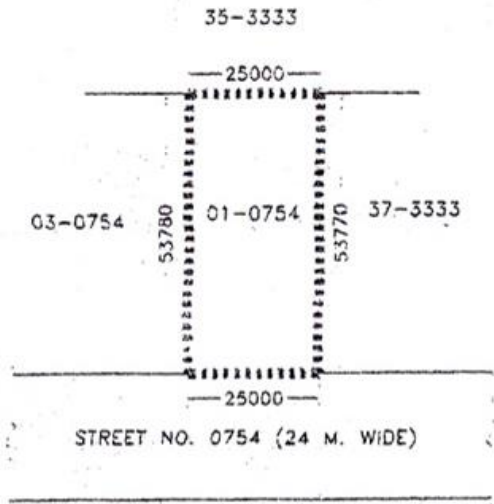
